During their March meeting, the Chico Tourism Committee discussed two new projects with funding requests. The first was a proposal from DCBA for EBC to be the title sponsor of the Thursday Night Market (TNM). After discussion a final recommendation was made to sponsor the TNM with \$10,000 and up to \$5,000 in-kind/advertising creative. The second project was a sponsorship to support the 150-Year Celebration of Chico turning 150 years old. The committee supports a \$10,000 sponsorship to support the creation of the calendar of events and to help advertise the campaign. Additionally, EBC has offered a partnership with the creation of a Bandwango pass for this campaign as well.

**Recommendation:** To allocated up to \$15,000 to support DCBA for Thursday Night Market and to allocate \$10,000 to the 150-Year Celebration of Chico.

### 4.2 CONSIDERATION OF OROVILLE TOURISM COMMITTEE RECOMMENDATION FOR ALLOCATING MORE OF THEIR ANNUAL BUDGET

During their February Meeting the Oroville Tourism Committee discussed a plan for allocating the majority of their \$27,919.29 budget for the year. The committee would like to recommend \$10,000 be allocated to buy advertising using already-owned assets, \$10,000 to support advertising of the new Oroville brand that the City is working on, and \$5,000 to be used for event sponsorships throughout the year.

**Recommendation:** To allocate \$10,000 to be used to buy advertising with already-owned assets, \$10,000 to support advertising of the new Oroville brand when the City is ready start advertising, and \$5,000 to support local events with sponsorships.

#### 4.3 CONSIDERATION OF YEAR END ADJUSTMENTS TO EQUITY ACCOUNTS

Income for the final quarter for 2021 are being collected but all expenses have been expended. The Finance Committee made changes to how EBC reserves funds earned from previous years to ensure funds are available for future projects. In 2021 those reserved funds were expended on various projects and the Board is required to take action to move those funds as already pre-approved. ### 4.4 CONSIDERATION OF RESERVING FUNDS EARNED BUT NOT SPENT IN 2021 TO BE SPENT IN 2022 ON ADDITIONAL PROJECTS

EBC collected more program income than budgeted in the 2021 calendar year and staff is recommending that the additional income be used for various projects not already budgeted for in 2022. Included in the recommendation is \$120,000 for advertising campaigns and creative to continue to promote our established campaigns, like *How We Winter* and *Restaurant Week*, \$50,000 to reskin the EBC website with the updated brand, and \$25,000 to reprint the Adventure Guide for remainder of 2022. The total amount requested is \$195,000. Detailed breakdown included in board packet.

**Recommendation:** To approve the recommendation to reserved \$195,000 earned in the previous year to spend in 2022 as outlined above.

### **ARTICLE VII**

### **OFFICERS**

**Section 1: Offices Held**. The officers of the corporation shall be a President, a Vice President, a Secretary, a Treasurer, and such other officers as the Board may from time to time designate. All officers shall be Directors. Any number of offices may be held by the same person, except that the Secretary and the Treasurer may not serve concurrently as the President.

**Section 2: Election of Officers**. The officers of this corporation shall be chosen annually by the Board and shall serve at the pleasure of the Board, subject to the rights of any officer under any employment contract.

**Section 3: Term**. The President and Vice President shall be elected for a term of one (1) year or until their successors are elected and qualified. The Secretary and Treasurer shall be elected for a term of two (2) years or until their successors are elected and qualified.

Section 7: Responsibilities of President. Subject to the control of the Board, the President shall be the executive officer of the Corporation and shall supervise, direct, and control the Corporation's activities, affairs, officers, and staff. The President shall preside at all meetings of the Board. The President shall have such other powers and duties as the board or the bylaws may require. Additionally, the President shall be authorized to sign checks, drafts, endorsements, notes and evidence of indebtedness of the Corporation issued by the Corporation.

**Section 8: Responsibilities of Vice President**. If the President is absent or disabled, the Vice President, if any, shall perform all duties of the President. When so acting, the Vice President shall have all powers of and be subject to all restrictions on the President. The Vice President shall have such other powers and duties as the board or the bylaws may require.

**Section 9: Responsibilities of Secretary**. The Secretary of the corporation shall have the following responsibilities:

A. The Secretary shall keep or cause to be kept, at the corporation's principal office or such other place as the Board may direct, a book of minutes of all meetings, proceedings, and actions of the Board, and of committees of the Board. The minutes of meetings shall include the time and place that the meeting was held; whether the meeting was annual, general, or special, and if special, how authorized; the notice given; the names of persons present at Board and committee meetings; and any action taken and the vote or abstention on that action of each Director present for the action.

- B. The Secretary shall keep or cause to be kept, at the corporation's principal office, a copy of the Articles of Incorporation and Bylaws, as amended to date.
- C. The Secretary shall keep or cause to be kept, at the corporation's principal office or at a place determined by resolution of the Board, a record of the Corporation's Directors, showing each Director's name, address, and business represented.
- D. The Secretary shall give, or cause to be given, notice of all meetings that these Bylaws require to be given. The Secretary shall keep the corporate seal, if any, in safe custody and shall have such other powers and perform such other duties as the Board or the Bylaws may require.
- E. The Secretary shall maintain, or cause to be maintained, the corporation's records in accordance with the requirements of the California Public Records Act, Government Code §6250 et seq.

**Section 10: Responsibilities of Treasurer**. The Treasurer of the corporation shall have the following responsibilities:

- A. The Treasurer shall keep and maintain, or cause to be kept and maintained, adequate and correct books and accounts of the corporation's properties and transactions. The Treasurer shall send or cause to be given to the Directors such financial statements and reports as are required to be given by law, by these Bylaws, by the BCTBID Management District Plan, or by the Board. The books of account shall be open to inspection by any Director at all reasonable times.
- B. The Treasurer shall deposit, or cause to be deposited, all money and other valuables in the name and to the credit of the corporation with such depositories as the Board may designate; shall disburse the corporation's funds as the Board may order; shall render to the President and the Board, when requested, an account of all transactions as Treasurer and of the financial condition of the corporation; and have such other powers and perform such other duties as the Board or these Bylaws may require.

#### Reason Interested:

In 2013, while I was employed with the County of Butte as the Economic Development Manager, I was successful in securing grant funds for the development of a Regional Marketing and Tourism Strategy. At the time, the County provided minor funding for tourism marketing. Approximately \$26,000 annually was received in Transient Occupancy Tax, all of which was expended on a small tourism and marketing contract to help get the word out about Butte County as an excellent place to visit and recreate. Understanding that such a small effort and small amount of funds would not make much of an impact in our region, the County was interested in learning more about how best to pursue a longer-term successful strategy.

The main finding that came from the Regional Marketing and Tourism Strategy is that in order for the County to be successful in any effort, they first needed to secure reoccurring funds that could be targeted for such a use. The report found that the establishment of a Tourism Business Improvement District (TBID) would be the best tool.

I then led the discussion with the other local jurisdictions within the County to determine their interest in pursing a TBID. Ultimately the jurisdictions came together, and funded the initial TBID formation effort, and Explore Butte County came into being in 2015.

When the original Board was elected for EBC, I asked to be considered for an At-Large position and was ultimately selected and served for several years. During that time, I was active in the

Finance Committee, the Marketing Committee, the Nomination Committee, and many other functions that arose during the initial years. When my employer changed, I needed to step down from my Board position, but have remained interested and active in other areas around tourism and community promotion.

Recently, I was hired as the Deputy City Manager for the City of Chico. In this role, I am responsible for managing the economic development function of the City. Since my employment with the City, we have had much conversation and collaboration with EBC regarding local tourism marketing.

Being a person that has grown up in Chico, and been employed in various positions throughout Butte County in Community and Economic Development over the past 20+ years, I understand our region. I am committed to moving our region forward, and feel that the tourism industry plays a key role in in revenue and business generation.
